**ACTION REQUESTED:** The Superintendent recommends award and subsequent purchase order to Capital City Gutter, the responsible and responsive bidder meeting all requirements who submitted the lowest total bid in the amount of \$215,000.00.

**ITEM SUMMARY:** The Maintenance Department issued an Invitation to Bid (ITB) 2420-2025 for Deerlake Gutter Replacement Project . Two (2) Contractors submitted a bid in response to the above referenced Invitation to Bid. It is recommended that Bid 2420-2025 Deerlake Gutter Replacement Project s be awarded to the responsible and responsive bidder meeting all requirements, Capital City Gutter who submitted the lowest total bid in the amount of \$215,000.00.

A legal notice was publicly advertised in the local newspaper, DEMANDSTAR broadcasted the Invitation to Bid to 1599 firms and the Invitation to Bid was posted to the district's purchasing website. Six (6) vendors attended the mandatory prebid meeting.

Per Section 120.57(3), Florida Statutes (F.S.), a Notice of Intent to Protest or a Formal Written Protest must be filed with the District's Purchasing Department within the timeframes established in law. Filings may be made physically at 3397 W. Tharpe Street, Tallahassee, Florida 32303, or via email to [bidprotests@leonschools.net](mailto:bidprotests@leonschools.net). Protests must comply with Rules 28- 110.003 and 28-110.004, Florida Administrative Code (F.A.C.). Filings received on a weekend, District holiday, or after 5:00 p.m. will be filed the next business day. Failure to file a protest within the time prescribed in Section 120.57(3), F.S., or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, F.S.
