Federal Grant Program

Purpose

The purpose of Title I, Part A is to increase student achievement by supplementing and enhancing state funding in specific areas of need (Every Student Succeeds Act, 2015).

- •Supplemental Program/Funding
- Economically Disadvantaged
- •Increase Student Achievement
- •Strengthen Parent and Family Engagement
- •Models-Schoolwide Plan (public & charter)/ Equitable Services (private)

Federal Grant Programs Recipients

As the Local Education Agency (LEA), Leon County Schools serves as the grant manager for all students and their schools within the county-wide service area. This includes traditional public schools, private schools, and charter schools. The equitable amount of service dollars provided to a site is based upon the criteria outlined by federal and state guidance.

Title I Part A 2025-2026

Criteria: Income Eligible (free or reduced lunch, government approved program), Survey 3

18 Traditional Public Schools

- 1 Special Site
- 1 Public Charter
- 9 Private
- Skipped schools receive additional local or state funding that meets or exceeds Title I allocation (Pace Center for Girls)
- At least 1% of budget allocated for Parent Engagement (FDOE 2% cap)
- At least 80% of funds-personnel, schools, tutoring

Allocation Process

(Not a comprehensive list of factors impacting Title I allocations)

- FTE Survey 3+ Eligible Students+ Eligible Private Students+ Total Schools (public, charter, private) = Title I Allocation
- Carryforward (Roll-Forward)- unused funds from public, charter & private
- Private school share (include roll-forward) must remain separate from public funds
- Comprehensive Needs Assessment required

Should serve schools in greatest need

Title I Program- Supplemental Services

Areas of Focus (not a comprehensive list)

Student Achievement- classroom teacher, interventionist, academic coach, para, software, educational field-trip, tutoring/enrichment program, classroom materials and supplies

Parent and Family Engagement- materials to support parent workshops, light refreshments or meal as appropriate

Early Childhood- salary and benefits for para professionals to extend pre-K hours

Foster Care Transportation- Leon County Schools Transportation Services for foster care students

Homeless Education- extended counseling services

Neglected & Delinquent – PACE Center for Girls classroom academic support (para professional)

Services Funded at LEA Level- ESOL Classroom materials, ESOL Translation Services, tutoring, professional learning

Administrative Cost- Title I department salaries and benefits, indirect cost, materials and supplies, professional learning

Equitable Services- (Private School Share)- contracted tutoring services, software, technology, materials & supplies, professional learning-travel

Tutoring Take Aways:

- Tutoring starts in Fall vs Spring
- Summer and Saturday Tutoring Sessions
- Targeted sessions based on student data (schools provide plan)
- Increased number of schools earning A, B, or C
- Continued para professional support
- Title I funds helps schools who do not have UniSiG or other funds
- 2025-2026- each public and charter allocate \$5,370.41(includes benefits




Academic Support- Florida Vision

- Open to all Title I Schools
- Grant funded
- Pre-K through 12th students
- Eligibility determined by Heiken Vision
- Free exam
- Free eyeglasses
- Free fitting
- Deliver to school or home
- Free doctor follow-up
- Free replacement glasses (within 6 months of receiving glasses)

Leon County Schools- 3rd year grant recipient-

Over 1380 students served. Close to half needed glasses.
