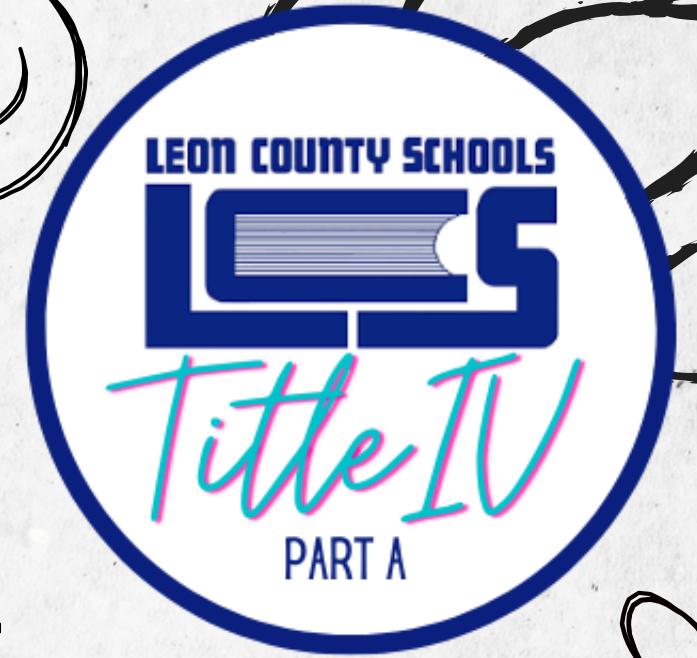




# Title IV, Part A Overview

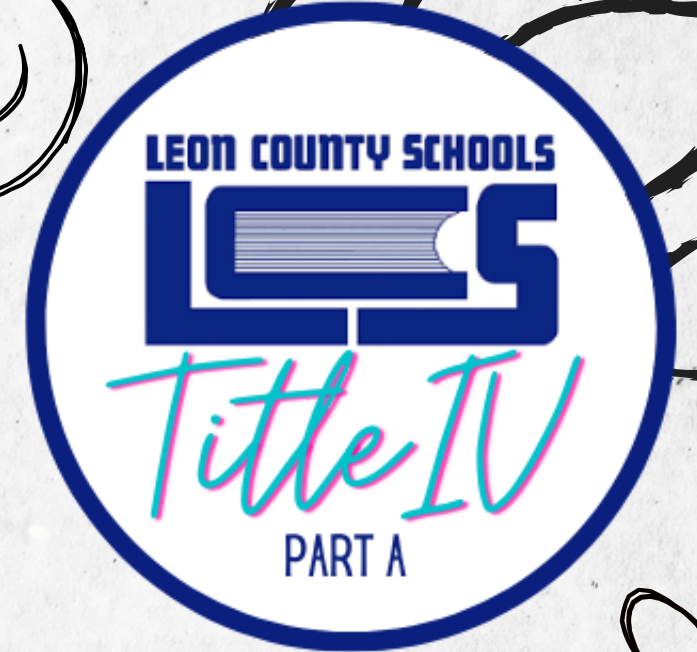




## **Title IV, Part A is a Federal “Student Support and Academic Enrichment Grant”**

Under this state-administered grant program, states allocate at least 95 percent of their Title IV, Part A funds to school districts to support activities in three program areas outlined in the law

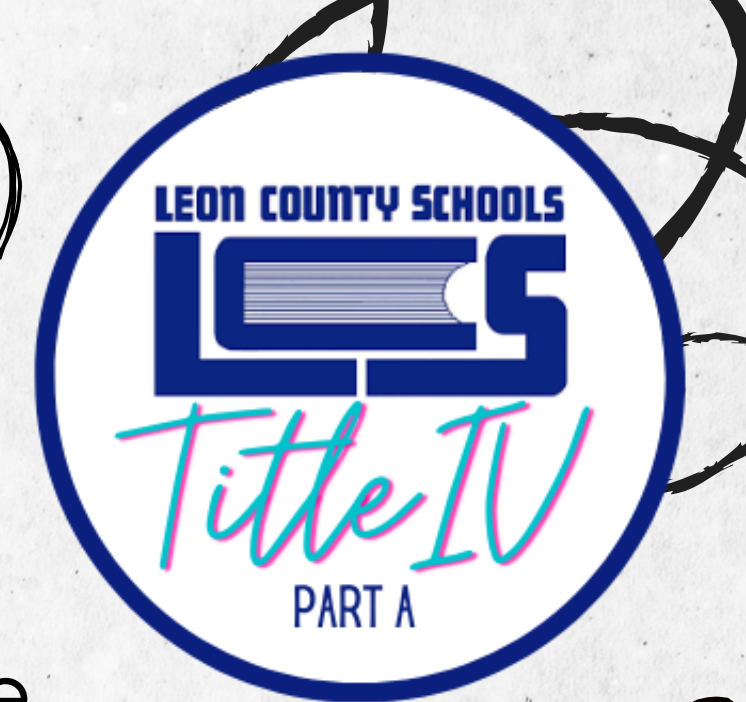




## Title IV, Part A Equitable Services

Sections 1117 and 8501 of the Elementary and Secondary Education Act (ESEA), as amended by the Every Student Succeeds Act (ESSA), require participating local education agencies (LEAs) to provide eligible private school students, their teachers, and their families with services that are equitable to those services provided to eligible public school students, their teachers, and their families.

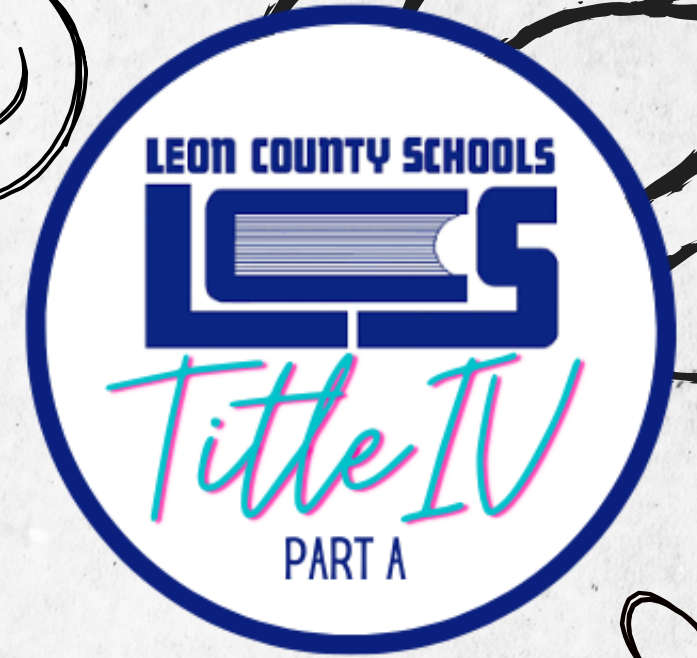




The purpose of Student Support and Academic Enrichment is to improve student academic achievement by increasing the capacity of state and local educational agencies in the following areas by:

- providing all students with access to a well-rounded education,
- improving school conditions for student learnings to support safe and healthy students, and
- improving the use of technology in order to advance digital literacy of all students.



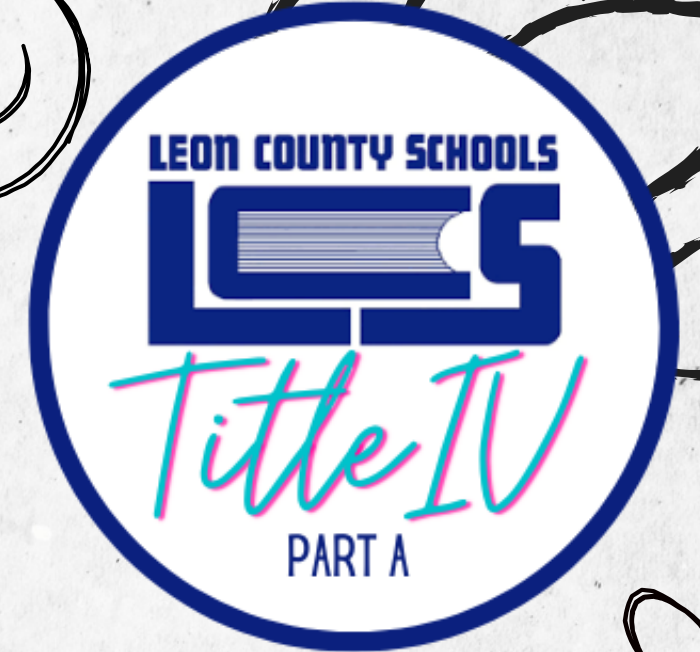


## Well-rounded Educational Opportunities

This component is to provide unique educational opportunities that help students make important connections among their studies. These connections help students become critical thinkers and productive members of society

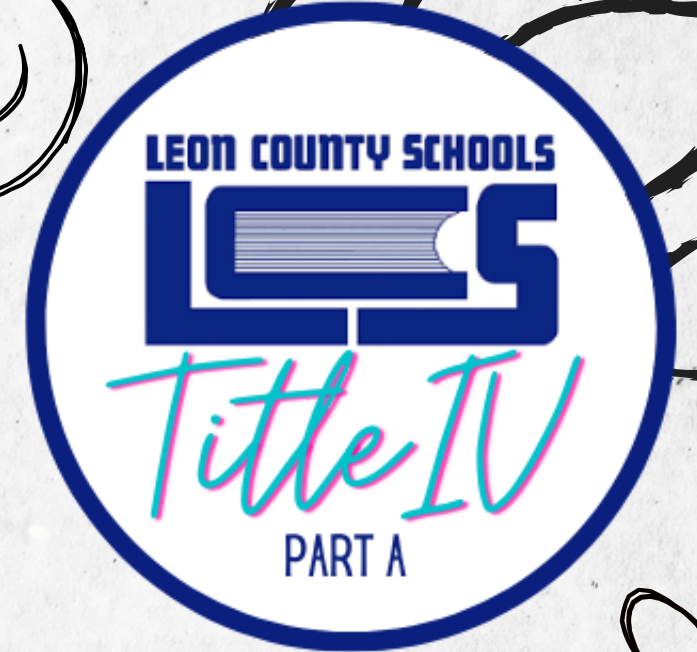


# Examples of Well-rounded Educational Opportunities activities Leon County has implemented:

- Math Manipulatives

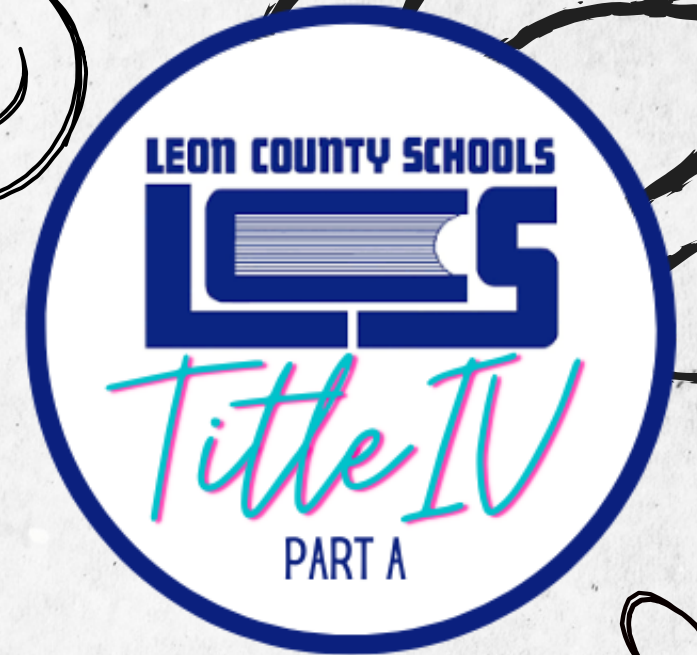




# Safe and Healthy Students and School Conditions

This component allows districts to create programs or activities that foster safe, healthy, supportive, and drug-free school environments. This includes setting up mental health counseling, PBIS programs, social and emotional learning programs, nutrition and physical education, and building parental and community relationships.



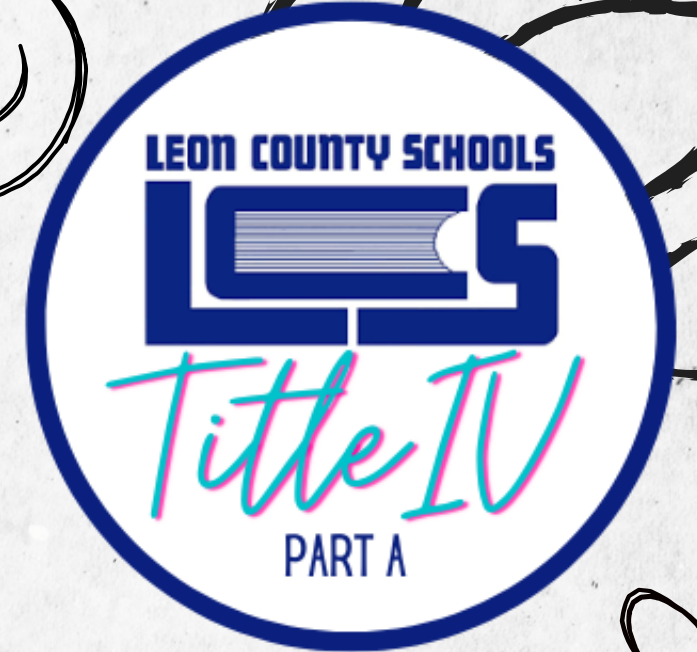


## Examples of Safe and Healthy Students and School Conditions activities that LCS has implemented:

- Professional Development for teachers

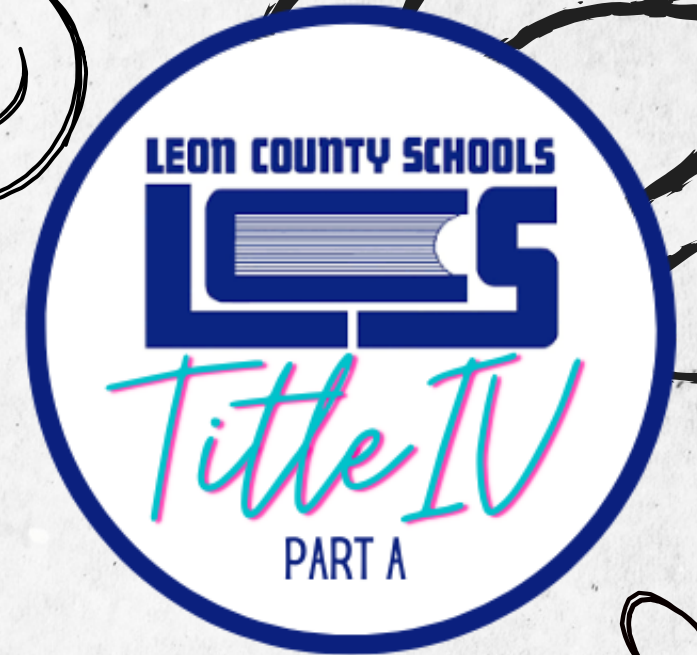


# Effective Use of Technology and Digital Literacy

There is less emphasis on the purchase of hardware and more on the professional development that supports teachers learning how to use technology to engage students

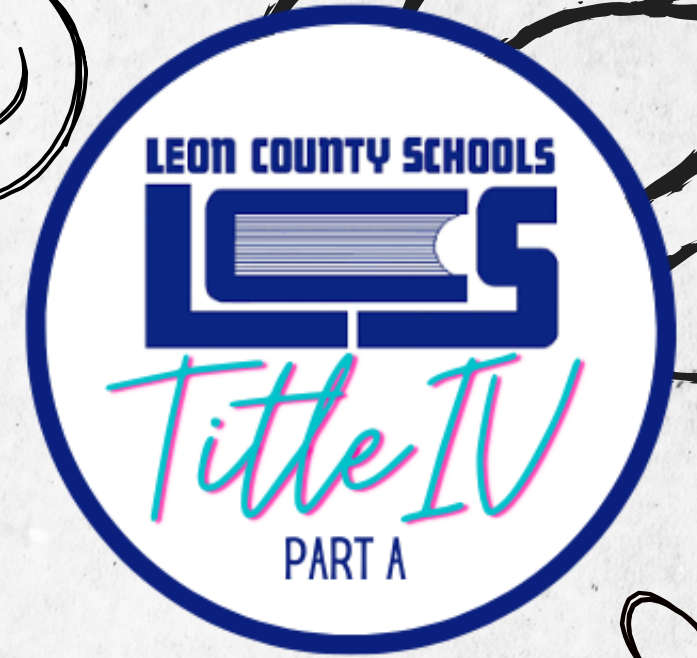




## Examples of Effective Use of Technology and Digital Literacy activities LCS has implemented:
