Students may be dropped off (in the designated safe area at the rear or front of the school) beginning at 7:45 a.m. Supervision begins at 7:45. Car riders must be picked up by 3:20 p.m., unless enrolled in the Extended Day Enrichment Program. Afternoon pick up is at the rear of school only. Our "Gathering" place is intended only for families who live within walking distance of the school, NOT for people to park and walk up. This is for the safety of all. The Avondale gate is only intended for students who live in that neighborhood.

ARRIVAL AFTER THE TARDY BELL

A student who is not in the classroom by the time the tardy bell sounds is to report to the main office for a tardy slip, unless one is given to them at drop off. Students arriving late must sign in the front office by a parent/guardian. Repeated tardiness may affect student performance, school choice status and establish patterns for adult life.

ABSENTEE PROCEDURE

Parents email the student's teacher *AND COPY* bles-attendance@leonschools.net explaining the reason for an absence. Absences or tardies due to a doctor appointment require a note from the doctor for an excuse. LCS Policy and the school administrator determine whether or not the reason is considered excused or not excused. Excessive absences or tardies will be reported to the guidance counselor. IMPORTANT: see LCS attendance policy linked below.

ATTENDANCE POLICY

The Leon County School District has an attendance policy which requires students to arrive at school on time each day, to participate in the complete school day by not being signed out prior to the dismissal bell, and to attend school every day unless they are ill. This policy and the possible consequences for excessive absences or truancy will be made available to all parents and their children at the beginning of the new school year.

CLINIC AT BUCK LAKE (850) 488-5264

The school clinic is open during school hours each school day. The person assisting is not a nurse. The clinic is a temporary resting place. If a child becomes seriously ill or is injured at school, a parent/guardian will be notified by to come to school to pick up the child. Please make sure your correct contact information and phone numbers are on file in FOCUS. Parents are able update their own phone numbers in FOCUS.

COLD OR RAINY DAY PROCEDURES

On cold days (generally below 40°), or days when there is inclement weather, students will report before school to an area inside the building. Grades K/1/2 will be in the cafeteria and grades 3/4 will be in the media center and 5th in the exploration lab.

CUSTODY OF CHILDREN

School personnel are bound by law to release children to parents unless we have, on file, a copy of a court order which grants exclusive custody to one parent or to a third party. It is your responsibility to provide the school with the most current, certified copy of the appropriate legal documents.

DRESS CODE

Students are to be dressed in appropriate, clean, comfortable clothing, as well as appropriate shoes on PE days. The LCS Student Code of Conduct designates the principal as the arbiter of student dress and grooming.

EXTENDED DAY ENRICHMENT PROGRAM

Buck Lake offers an Extended Day Enrichment Program, a before and after school care program for children. The cost is based on the number of days a student will be attending the program. FOCUS PARENT PORTAL

All custodial parents/guardians are allowed and encouraged to access their student's grades, attendance, health and contact information through the FOCUS parent portal. Each custodial parent/guardian may set up their own account. Siblings should be linked for easiest viewing. Certain information can be edited by the parent/guardian holding the account. For any other edits, such as change of address, please upload your two, acceptable proofs of residence in your FOCUS account or email your two proofs to chapmanl2@leonschools.net (FOCUS COMMUNITY INFORMATION is used to disperse school information publicly to individuals who don't already receive messages from FOCUS as a custodial parent account holder.)

FORTIFY FL APP

The FortifyFL app is LIVE. Now, any student, educator, parent, or member of the public can report school safety concerns directly to law enforcement and school administrators anonymously and easily through the FortifyFL app or www.getfortifyfl.com. The app, which is available for download on Apple and Android mobile devices, is critical to ensuring all Florida schools are safe environments where students and educators can experience and share the joy of learning without fear. INTERNET

Students and employees are offered an opportunity to enhance learning through the accessibility of the Internet. With this opportunity comes the responsibility for appropriate use. The use of the Internet is a privilege, and inappropriate use will result in cancellation of that privilege. Any user of Leon County Schools Internet connections must be properly authorized by parent/guardian permission in FOCUS.

LEAVING SCHOOL EARLY/CHANGES

Any student leaving school early must be signed out by a parent or guardian in the main office. As an added measure of security for our children, every person who picks up a child must show some form of photo identification when asked. **MAKE PLANS IN ADVANCE!** Let your child know what to do when there is a change of plans or if it's raining at dismissal time. *Messages from parents making a change in the way their child is to leave school will be accepted until noon.* Students are not allowed to be checked out after 2:30 due to staff constraints.

LOST AND FOUND

Lost items are kept in the cafeteria and will be donated to a charity regularly if not claimed. We strongly encourage you to write your child's first name and last initial at the very least on their belongings so they may be returned.

MEALS

Our school is designated as a Community Eligibility Provision (CEP) school. CEP allows our school to serve breakfast and lunch at no charge to all enrolled students. MEDICATION

Students are not to bring medication of any kind to school. Parents of students requiring medication are to come to the school's clinic to complete and sign an Administration of Prescription Medication School Permission Form, which is required if medicine must be given at school. Students are not to have medicine in their possession at school. All medicine is kept locked in the school's clinic.

PARENT - TEACHER CONFERENCE

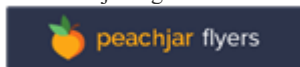

PEACHJAR EFLYERS

Leon County Schools uses a digital flyer delivery as part of its efforts to be more environmentally friendly and to embrace innovative technology. Using the Peachjar eflyer program, eflyers are sent directly to parents' email inboxes as well as posted on school websites for easy access. PIKMYKID

In an effort to increase safety and efficiency of student pick up BLES uses a digital dismissal program called PikMyKid. This system uses an app to let the school know when parents/guardians arrive at the school so that students will be released from their classroom, in real time, to their car. Every child will be given a code that will need to be written on a car tag and parents/guardians will also need to download and register for the free app PikMyKid

PROGRESS ALERTS

Progress alerts are provided through the FOCUS parent portal to families midway through the grading period. You can monitor your child's progress through the Parent Portal at any time. Only custodial persons are allowed access to the Parent Portal.

PTO (Parent Teacher Organization)

PTO meetings are held monthly and are generally scheduled to begin at 5:30 p.m. All parents are encouraged to join PTO. REPORT CARDS

However, parents of kindergarten students will attend a conference for the first nine week grading period to discuss their child's progress.

VISITING AT BUCK LAKE

Visitors on campus should bring a driver license with them and must always sign in at the main office and wear an identification tag issued by the office whenever they are present on school property. Parents/guardians are welcome to visit their child during their scheduled lunch period.

VOLUNTEER / MENTOR PROGRAM

School volunteers and mentors are very special people, all volunteers/mentors must **annually** complete a volunteer application/screening.
