REIMBURSEMENTS Reimbursements from internal accounts to employees are prohibited with the exception of gas and travel reimbursements. All internal accounts purchases should be processed using a school check or the Internal Accounts P-Card. Staff should make every effort to plan in advance for their school-specific expenditures.
