

## **GROUP ADDITIONAL LIFE INSURANCE**

# We can help provide for your family when you can't.

Group Additional Life insurance can help protect your family's finances if something happens to you. This coverage can help provide financial support and stability to your family if you pass away.

Additional Life insurance can help make things easier for the people you care about.

**Life insurance** helps protect the people who depend on your income by paying them an amount of money specified in the policy if you die.

Life insurance is an easy, responsible way to help your loved ones during a difficult time — and into the future.

## What's at stake.

A death might leave your family facing expenses they couldn't pay without your income. That could include extra costs for medical care or a funeral.

You're covered under Basic Life insurance if you take no action, provided you meet the eligibility requirements. But if Basic Life insurance doesn't meet your needs, you can apply for additional coverage. Plan now to help your family cover future expenses like:

## **How Much Can I Apply For?**

Your combined Basic Life and Additional Life amounts cannot exceed a maximum of 6 times your annual earnings.

Note: You cannot buy more coverage for your spouse or child(ren) than you buy for yourself.

The coverage amount for your spouse cannot exceed 100 percent of your Additional Life coverage.

The coverage amount for your child(ren) cannot exceed 100 percent of your Additional Life coverage.

#### For You:

\$10,000-\$250,000 in increments of \$10,000

## For Your Spouse:

\$5,000-\$125,000 in increments of \$5,000

## For Your Children:

Option of either: \$5,000 or \$10,000

## What Is The Guarantee Issue Amount?

Depending on your eligibility, this is the maximum amount of coverage you may apply for during initial enrollment without answering health questions.

## For You:

Up to \$150,000

## For Your Spouse:

Up to \$50,000

See the Important Details section for more information, including requirements, exclusions, limitations, age reductions and definitions.

## Annual Open Enrollment

**For You.** If you are currently enrolled in Additional Life insurance for an amount less than \$150,000, you may elect to increase your coverage by \$10,000, up to, but not to exceed, the guarantee issue amount of \$150,000 without having to answer health questions.

**For Your Spouse.** If your spouse is currently enrolled in Dependents Life insurance for an amount less than \$50,000, you may elect to increase coverage by \$5,000, up to, but not to exceed, the guarantee issue amount of \$50,000, without having to answer health questions.

## Additional Feature

### **Accelerated Benefit**

If you become terminally ill, you may be eligible to receive up to 75 percent of your combined Basic and Additional Life benefit to a maximum of \$500,000.

## How Much Your Coverage Costs

Your Basic Life insurance is paid for by Leon County School Board. If you choose to purchase Additional Life coverage, you'll have access to competitive group rates, which may be more affordable than those available through individual insurance. You'll also have the convenience of having your premium deducted directly from your paycheck.

How much your premium costs depends on a number of factors, such as your age and the benefit amount.

## Use this formula to estimate your tenthly premium payment:

Enter the amount of coverage you are requesting (see benefit amounts on page 2).			Enter your rate from the rate table below.	_	This amount is an estimate of how much you would pay tenthly.

If you buy coverage for your spouse, your tenthly rate is shown in the following table. Use the same formula to calculate the premium that you used for yourself, but use your age and your spouse's rate.

If you buy Dependents Life for your child(ren), your tenthly rate is \$0.24 per \$1,000, no matter how many children you're covering.

## **Important Details**

Here's where you'll find the nitty-gritty details about the plan.

## **Eligibility Requirements**

To be eligible for coverage, you must be:

- Insured for Basic Life insurance through The Standard
- An active employee of Leon County School Board, other than a substitute, OPS employee, summer school employee and hourly-as-needed teacher regularly working at least 17.5 hours per week
- An active board member of Leon County School Board

Temporary and seasonal employees, full-time members of the armed forces, leased employees and independent contractors are not eligible.

If you buy Additional Life insurance for yourself, you may also buy Life coverage for your eligible child(ren) and/or spouse. This is called Dependents Life insurance.

You can choose to cover your spouse, meaning a person to whom you are legally married.

You may also choose to cover your child. Child means your unmarried child from live birth through age 29.

#### Please note:

- Your child cannot be insured by more than one employee.
- Your spouse or child(ren) must not be full-time members of the armed forces.
- You cannot be insured as both an individual and a dependent.

### **Medical Underwriting Approval**

Required for:

- Coverage amounts higher than the guarantee issue amount
- All late applications (applying 31 days after becoming eligible)
- Requests for coverage increases
- Reinstatements
- Employees eligible but not insured under the prior life insurance plan

Visit **standard.com/mhs** to submit a medical history statement online.

Note: If your family status changes, you may have the ability to apply for coverage or increase your coverage for a limited time without having to submit a medical history statement. Please see your human resources representative or plan administrator for more information.

### **Coverage Effective Date**

To become insured, you must:

- Meet the eligibility requirements listed in the previous sections,
- Serve an eligibility waiting period\*,
- Receive medical underwriting approval (if applicable),
- Apply for coverage and agree to pay premium, and
- Be actively at work (able to perform all normal duties of your job) on the day before the insurance is scheduled to be effective.

\*If you are already a member on the date the group policy is effective, you are eligible on the first day of the calendar month that coincides with or next following issuance of the first paycheck by the Employer. **OR** \*If you become a member after the group policy effective date, you are eligible on the first day of the calendar month that coincides with or next following issuance of the first paycheck by the Employer.

If you are not actively at work on the day before the scheduled effective date of your insurance including any Dependents Life insurance coverages, your insurance will not become effective until the day after you complete one full day of active work as an eligible employee.

Contact your human resources representative for further information about the applicable coverage effective date for your insurance, including Dependents Life insurance.

### **Age Reductions**

Under this plan, your coverage amount reduces by 35 percent at age 70 and by 50 percent at age 75. Your spouse's coverage amount reduces by your age as follows: by 35 percent at age 70 and by 50 percent at age 75.

If you or your spouse are age 75 or over, ask your human resources representative for the amount of coverage available.

## **Waiver of Premium**

Your premiums may be waived if you:

- Become totally disabled while insured under this plan,
- Are under age 60, and
- Complete a waiting period of 180 days.

If these conditions are met, your Life insurance coverage may continue without cost until age 65, provided you give us satisfactory proof that you remain totally disabled.

## **Portability**

If your insurance ends because your employment terminates, you may be eligible to buy portable group insurance coverage from The Standard.

## Conversion

If your insurance reduces or ends, you may be eligible to convert your existing Life insurance to an individual life insurance policy without submitting proof of good health.

#### **Exclusions**

Subject to state variations, you and your dependents are not covered for death resulting from suicide or other intentionally self-inflicted injury, while sane or insane. The amount payable will exclude amounts that have not been continuously in effect for at least two years on the date of death.

## When Your Insurance Ends

Your insurance ends automatically when any of the following occur:

- The date the last period ends for which a premium was paid
- The date your employment terminates
- The date you cease to meet the eligibility requirements (insurance may continue for limited periods under certain circumstances)
- The date the group policy, or your employer's coverage under the group policy, terminates
- For each elective insurance coverage, the date that coverage terminates under the group policy

In addition to the above requirements, your Dependents Life coverage ends automatically on the date your dependent ceases to meet the eligibility requirements for a dependent.

For more details on when your insurance ends, contact your human resources representative.

### **Group Insurance Certificate**

If coverage becomes effective, and you become insured, you may receive a group insurance certificate containing a detailed description of the insurance coverage including the definitions, exclusions, limitations, reductions and terminating events. The controlling provisions will be in the group policy. The information presented in this summary does not modify the group policy, certificate or the insurance coverage in any way.
